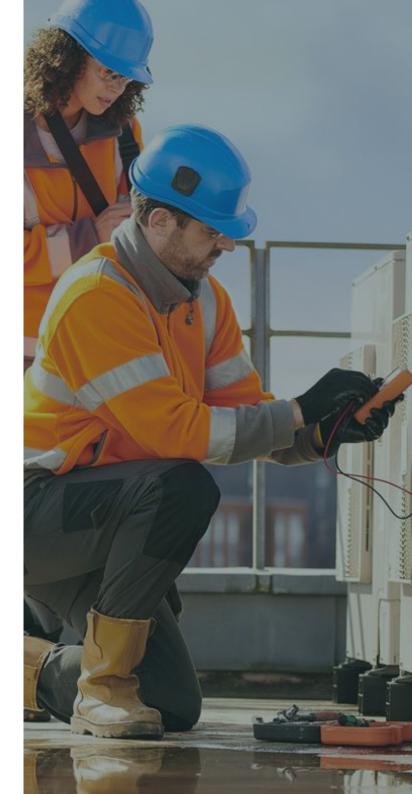


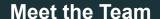

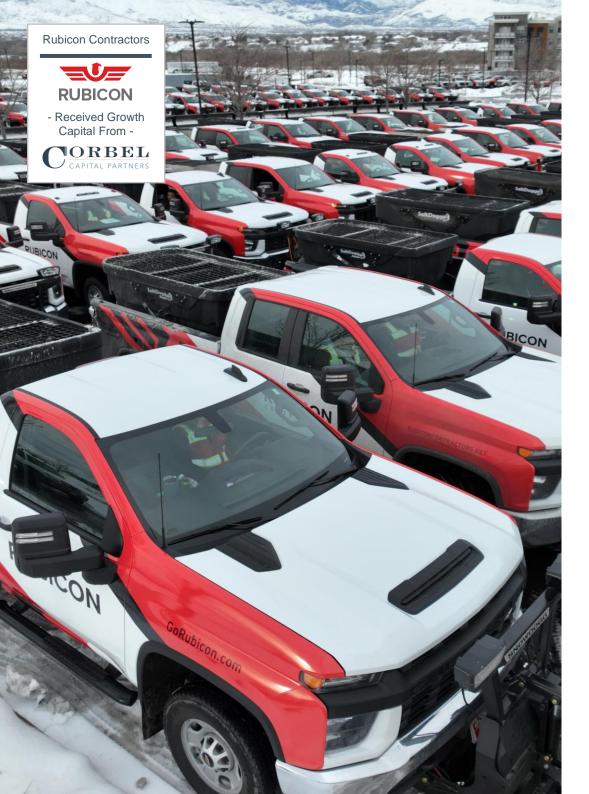

Key Facility & Industrial Services Industry Trends

Focus on Recurring, Recession-Resistant Revenue Streams

Predictable revenue streams based on maintenance and repair, consistently scheduled site visits, or periodic audits or certifications has allowed investors to confidently deploy capital, secure debt, and execute long-term growth plans

Outsourcing Trend Drives Demand

Businesses are progressively turning to external service providers to handle all non-core operations leading to increased demand for many facility & industrial services

Cross-Selling and Synergy Realization

Providing multiple services through a single customer touch-point allows platforms to drive revenue while streamlining cost structures

Robust and Accelerated M&A Activity

The highly fragmented and regional nature of the market has driven M&A activity within the facility & industrial services space. This has led to more expansion and accelerated strategic acquisitions aimed at consolidation



Facility & Industrial Services M&A Activity

COVID-19 slows M&A activity due to extreme uncertainty in growth forecasts and expected pricing dislocation from buyers Historically low interest rates, government economic stimulus, accumulation of dry powder, and pressure to deploy capital leads to a record period of M&A

M&A activity remains robust despite increased financing costs and broader macroeconomic and geopolitical challenges



- The facility & industrial services space has seen a heightened level of M&A and investment activity with runway to continue
- Following a record year of M&A activity in 2021, M&A activity has remained robust with 1,300+ deals in 2022 and 1H 2023
- The space has become increasingly attractive to private equity investors who focus on regional buy-and-build strategies, acquiring several local businesses to build scale, expand geographic reach, deepen/expand service capabilities, and realize economies of scale
- Strategics in the space have remained acquisitive focusing on expanding service offerings to serve as a "one-stop-shop" service provider
- Despite a heightened level of M&A activity, market fragmentation is still high in many service categories, with many founderowned businesses seeking ownership transitions, liquidity, or capital to support growth and acquisition strategies



Industry Segmentation – Soft Services

Soft services contribute to the functionality, aesthetic appeal, security, and wellbeing of employees, building occupants, and facility visitors. These services typically require higher labor intensity and lower technical skills.



Exterior Building Maintenance

Paving, window cleaning, power washing, glass restoration, sweeping, and waterproofing



Janitorial & Cleaning

Interior facility cleaning, floor care, window washing, construction clean-up, carpet cleaning, and vacuuming



Landscaping

Lawn / tree care, weed control, fertilization, irrigation systems, and snow / ice management and removal





Pest Control

Extermination, pest removal, infestation prevention, and restoration services





Restoration & Remediation

Disaster restoration, mold and asbestos removal, and water, storm, fire, and smoke remediation



Roofing

Roofing repair, maintenance, restoration, and replacement services





Waste & Recycling

Trash and recycling collection, dumpster services, and hazardous waste disposal / transportation







Industry Segmentation – Hard Services

Hard services maintain the physical systems and infrastructure of a facility, ensuring the safety, welfare, and productivity of building occupants. These services typically require higher skilled labor and are subject to regulatory imperatives.



Electrical & Building Controls

Wiring, power systems, low voltage and generators, interior / exterior lighting, and broadband



Elevator

Elevators, escalators, material handling systems, loading docks / doors, overhead cranes, and compactors / balers



Fire & Life Safety ("F&LS")

Fire sprinkler systems, fire alarms, fire monitoring services, fire doors, and fire extinguishers





HVACR

Heating, ventilation, air conditioning, and refrigeration installation, maintenance, and repair





Plumbing

Pipe draining, cleaning, and clearing, sewer system repair, septic tank drainage, and water heater maintenance





Security

Access control, alarm systems, and surveillance systems



Test, Inspection, Certification, & Compliance ("TICC")

Facility inspection, code and compliance, and system testing





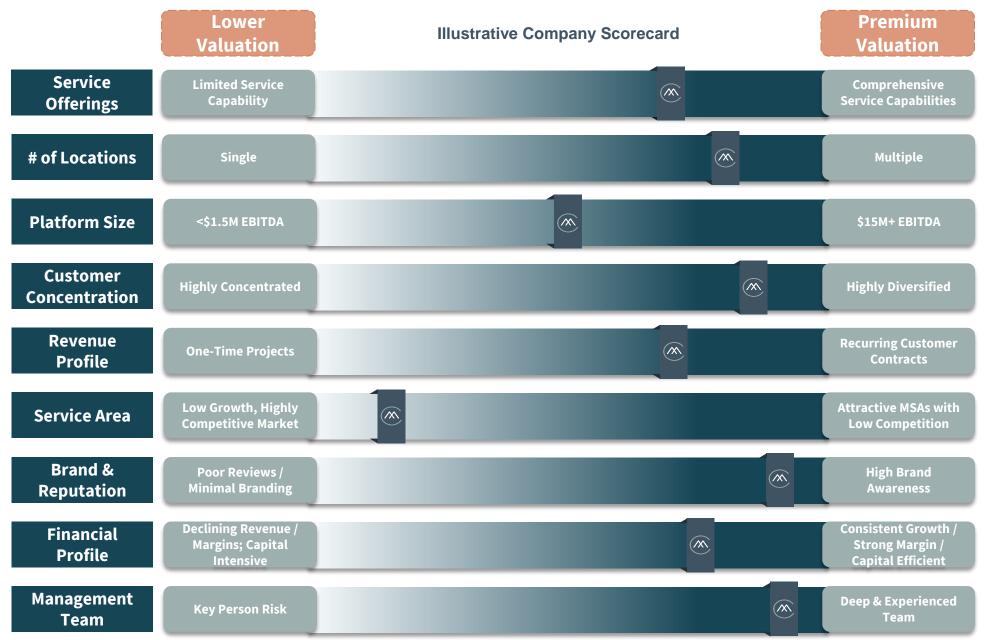
Facility & Industrial Services Valuation Dynamics

Active roll-up strategies have been deployed across the facility and industrial services spectrum with average valuations varying due to a variety of factors including level of technical labor required, gross margin profile, revenue recurrence dynamics and predictability, and capital intensity.

Fire & Life Safety Industry Trends

Regulatory Requirements Drive Demand

The National Fire Prevention Association has more than 300 codes and standards to minimize the risk of fire. These requirements are continually evolving and drive enduser demand

Increased Construction and Remodeling Activity

The demand for F&LS services will increase as new buildings are mandated to install fire protection systems. Remodeling must also adhere to these standards and update older fire protection systems

Environmental Effects Pose Opportunity

With the rise of global temperatures and record-breaking heat indices, fire risks have increased the demand for preventative counter-measures across the residential, commercial, and industrial end-markets

Modernization and Updating for Smart Buildings

The recent technology advancements in infrastructure through sensor data and artificial intelligence has led to increased volume of connected fire alarm systems operating wirelessly

HVACR & Plumbing Industry Trends



Essential Service

HVACR/plumbing investor demand is driven by the critical nature of services; businesses cannot function without these systems in place. The category has a combination of installation and recurring preventative work and break/fix demand

Private Equity Leads Consolidation

Private equity backed platforms have led consolidation in the HVACR and plumbing space with many executing on regional buy-and-build strategies. Private equity backed buyers represent 61% of Jan-23 to Sep-23 transactions

Aging Infrastructure

Aging infrastructure is anticipated to boost the demand for HVACR and plumbing maintenance, installation, upkeep, and retrofit services

New Technologies

Many HVACR and plumbing service providers are focused on integrating new technology to facility systems. This includes connected thermostats, remote monitoring, and control and energy optimization solutions

Landscaping Industry Trends

Diversification of Services

Landscaping companies have increasingly expanded their service offerings beyond traditional lawn maintenance. This includes snow and ice management, pest control services, turf management, and irrigation installation services

Ongoing Maintenance

A high percentage of revenue in the landscaping space comes from on-going maintenance and repair services (ex: bi-weekly lawn care program), leading to customer stickiness and recurring revenue

Outsourcing Trends

Businesses have continued to outsource landscaping services enabling cost-saving opportunities and access to a specialized workforce

Service Providers Benefit From Post-Pandemic Era

Service providers have benefited from increases in home ownership and return to office mandates as green space expands through suburbs and employers seek to create more attractive environments in urban spaces
