## Sector Overview & Trends

- M&A activity decreased in 2025 compared to recent years as investors and buyers cautiously evaluated impacts from macro consumer behavior and the effect of tariffs on internationally sourced product
- Consumers are moving away from generic, one-size-fits-all supplements towards personalized, customized regimens that are increasingly targeting gut and microbiome, sleep, and cognitive health
- With increasing awareness of mental health, a new, highly accessible category of supplements is emerging that is focused on cognitive and emotional well-being
- Protein continues to expand beyond its traditional athlete nutrition audience to become a dominant, multi-purpose ingredient for general health, GLP-1 nutrition programs, and convenience with a steady stream of alternative forms emerging (clear protein, energy and protein hybrids, etc.)

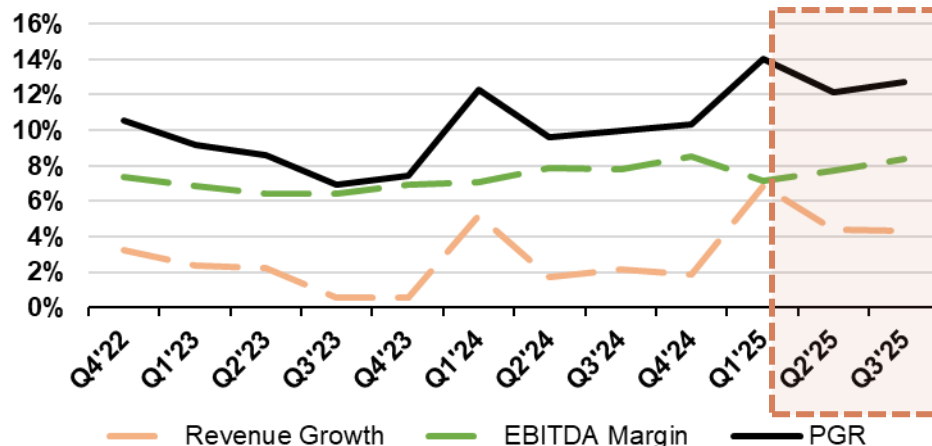


**Irwin Naturals** is a manufacturer of vitamins and dietary supplements using liquid soft-gel formations. The Company offers a wide range of targeted health products.

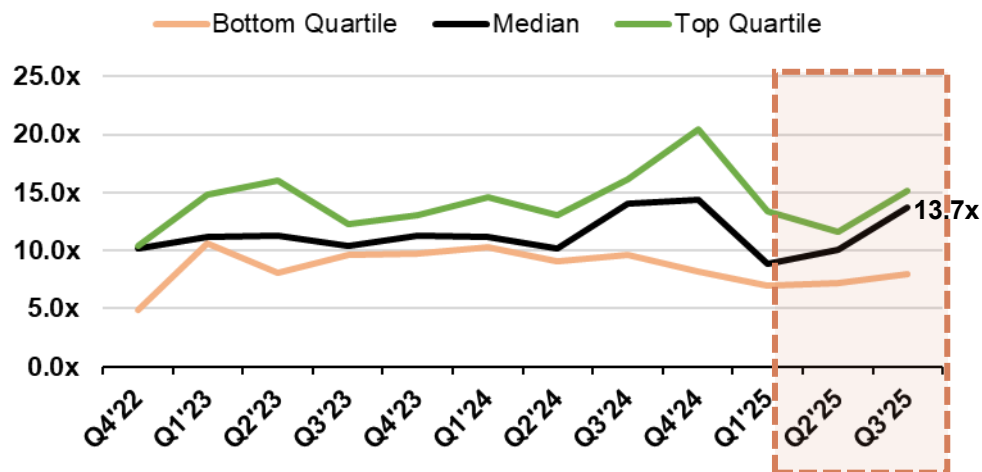
## Performance Metrics Over Time

Note: Profit Growth Ratio = EBITDA Margin + Revenue Growth

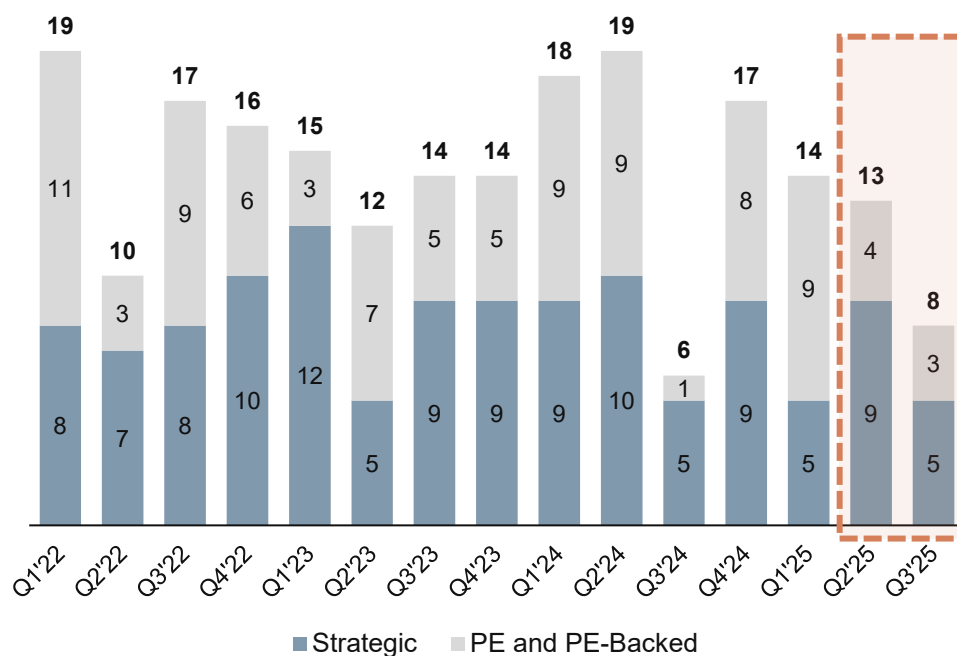
### EV / EBITDA Multiple – Public Companies

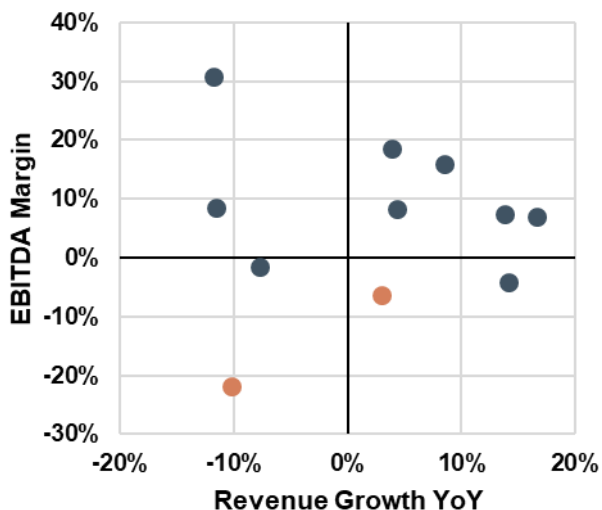

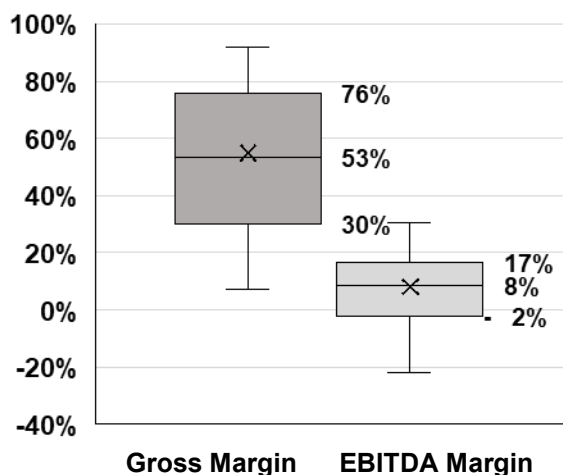

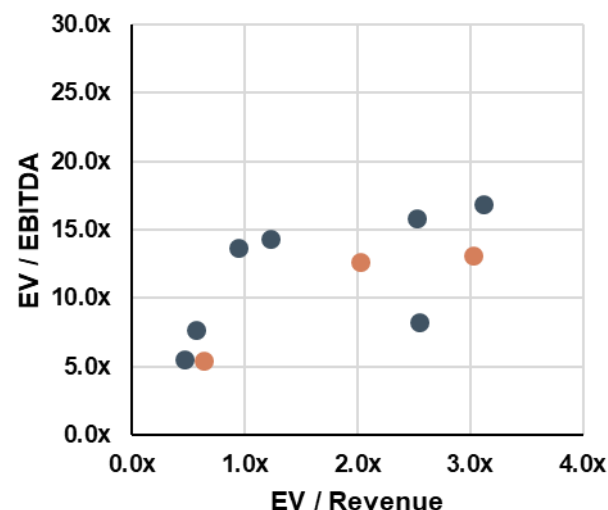
## Revenue Growth & EBITDA Margin
