



Key Market Trends in Security Services

Large and Growing Addressable Market for Systems and Services

The global commercial security systems market is estimated at \$223B in 2025 and is projected to grow at a 11.4% CAGR through 2030 reaching \$382B,¹ with demand driven by increasing security concerns, update needs for existing systems and infrastructure, and technological advancements in security and access control. As the install base continues to grow and increasingly more complex systems are introduced to the market, the installation, service, and monitoring market is expected to experience strong demand tailwinds.

Adoption of Cloud-Based Systems and Data-Driven Insights

Companies are increasing the adoption of cloud-based security and access control solutions, as system become more scalable, provide centralized management, and offer real-time monitoring capabilities. Business are able to better manage security across multiple locations through a single platform driving operational efficiencies. Further, systems can generate meaningful data and insights for businesses to leverage to optimize space utilization, manage energy consumption, and improve overall facility management.

Advancements in Access Control Solutions

Access control solutions continue to shift towards the use of biometrics, mobile credentials, and touchless systems to enhance security, convenience, and hygiene. Key biometric authentication methods include facial recognition, fingerprint, and iris scanning providing highly accurate and secure identification. Further, the use of Al and machine learning can provide advanced threat protection by analyzing patterns, detecting anomalies, recognizing behavior patterns, and generating real-time alerts.

Unified Platforms and Systems Integration

There is an increasing demand for unified security solutions that integrate across various systems including access control, video surveillance, and visitor management systems, among others. Cross-system integration streamlines monitoring and improves threat detection for the enduser, while enabling customers to have one service provider point-of-contact for the complete system. Security companies are seeking to expand their portfolios to better offer a single-source solution to customers and capture greater wallet share across security needs.

Attractive Industry Dynamics Driving Investor Interest

The security services market continues to experience strong investor interest with M&A activity led by PE-backed strategics executing on buy-and-build strategies. The combination of recurring revenue from service, monitoring, and maintenance services combined with the recession resilient nature of the industry provides attractive revenue visibility and earning stability for investors. As a fragmented market with many regional providers, there are meaningful opportunities for acquirors to build scale in key geographies and expand their service capabilities. Service providers with high recurring revenue and a comprehensive portfolio of tech-enabled services are attracting premium valuations.

A shift towards more technologically advanced and highly integrated systems is driving both install revenue and various recurring service revenue opportunities.






